

# ASFPM's Mission

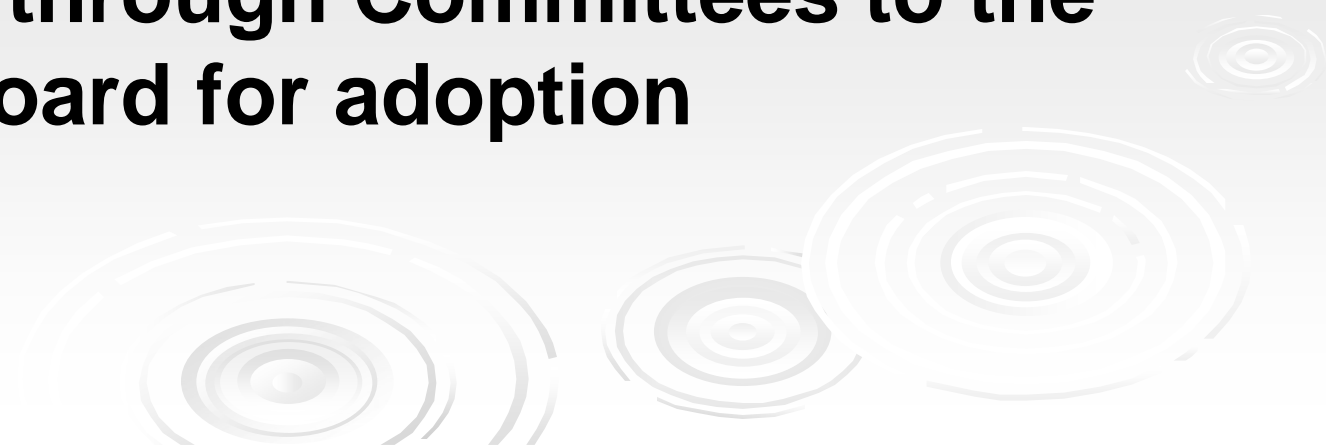
Protect the natural and beneficial functions of floodplains.



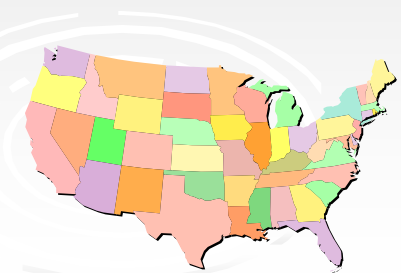



# 2008-2009 Legislative Update

- Stimulus Package 2009
- NFIP Reform 2009
- WRDA 2007—USACE authorization
  - National Levee Safety Program
- FY 2010 agency programs and budgets
- USGS Streamgages
- Mitigation—PDM, etc.



# NFIP Reform Issues

- Debt forgiveness
  - Map Mod
    - Extension of time
    - Expansion of tasks to include residual risk and 500 year floodplain
    - Authorize mapping at level of \$400 million per year for as long as possible
    - Re-establish Technical Mapping Advisory Council
- 

# NFIP Reform Issues

- Oppose Wind on NFIP policies
- Extension of mandatory purchase of insurance in residual risk areas
  - Preferred risk rate if levee is adequate
- Some premium increases
- Non-primary residences and non-residential structures should move to actuarial rates

# National Levee Safety Program

- WRDA 2007 - Authorized a National Levee Safety Committee to report:
  - develop recommendations for a national levee safety program, including a strategic plan for program implementation
- ASFPM provided input and comments- see our web site
- Committee developed a report sent to Congress on Jan 15, 2009




# **Review National Flood Programs & Policies - 2007**

- 22 major categories for policy on all federal programs impacting floods
- 270 recommendations
- Available on the ASFPM website



# National Coordination Activities

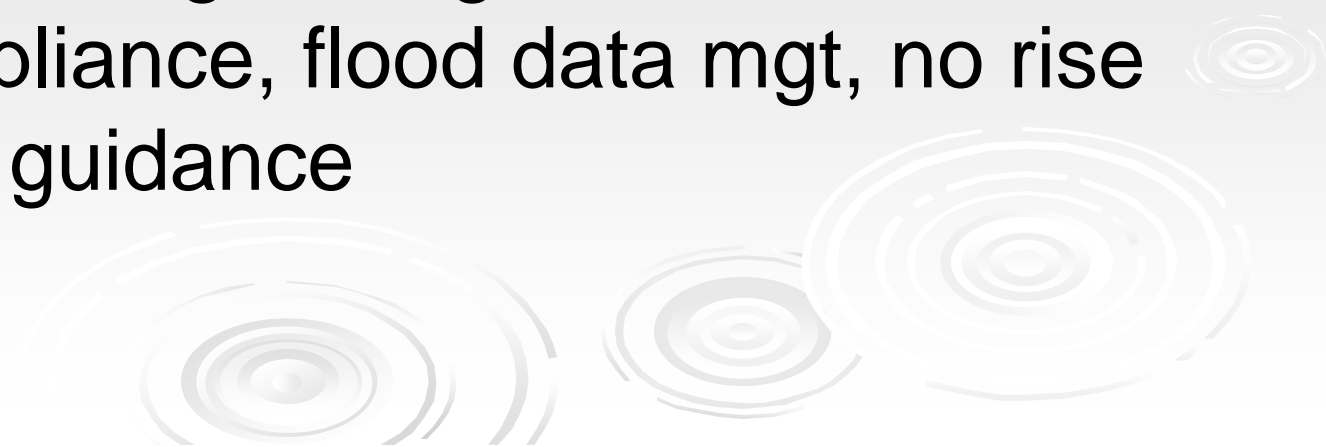
- Interagency Flood Risk Management Committee (IFRMC)
