

2011 IAFSM Annual Conference Exhibitor Registration

You are invited to exhibit during the IAFSM's Annual Conference. Speakers from federal, state, regional, and local agencies and the private sector will share their knowledge on current programs and the latest techniques. The conference provides both an excellent training forum and an opportunity to meet and talk with other floodplain and stormwater management professionals. Over the last few years, our conference has brought up to 400+ participants and 25 exhibitors. We will repeat our proven approach to encourage visitors to the exhibits. Registrants will receive an exhibitor's card. If each private exhibitor signs the card, the registrant will be eligible for the door prize drawing. We collect over 200 fully executed exhibitor cards each year. The door prizes will be drawn and announced at the luncheon on Thursday.

The registration fee for exhibitors is \$400 for a six-foot space. This includes registration for the conference for one person and includes that individual's IAFSM yearly membership. If you require more than a six foot space you will need to include an additional \$400 exhibitor fee which includes an additional attendee registration. You will receive conference packets and name tags. IF REQUESTED we will provide a table and two chairs. Or you may set up your own backdrop and display. Indicate your request at the bottom of the form.

Exhibits need to be set up before registration on Wednesday morning and taken down after the social hour on Wednesday evening. Setup time will be 5:30-9:00 pm on Tuesday, March 8 and 7:00-8:00 a.m., Wednesday, March 9. The social hour will be 5:30-7:00 p.m. Wednesday evening. *Note: Please stay set up until the social hour is over.*
