




Unit of measure for billing

Impervious Area





Treated like Non-Residential parcels due to the large amount of impervious area.



Non-Residential

>Residential parcels with greater than 7,000 sf

These are considered having significant impact and are charged like Non-Residential parcels

>All Non-Residential parcels

Fee is based on the number of ERUs or portion thereof.

Residential with Significant Impact



M \$68.58 Bi-M \$137.16 A \$822.96 18,090 / 3,300 = 5.48 ... round UP to 6 ERUs

Non - Residential Examples



46,744 / 3,300 = 14.16 ... round UP to 15 ERUs

> M \$171.45 Bi-M \$342.90 A \$2,057.40

37,511 / 3,300 = 11.37 ... round UP to 12 ERUs



1. SINGLE FAMILY RESIDENTIAL parcels are charged based on a tiered system:

Single Family Residential	2017 Monthly Fee	2018 Monthly Fee
Tier 1 (1-2,500 s. f. of impervious area) = .75 ERU	\$7.90	\$8.57
Tier 2 (2,501 - 4,000 s.f. of impervious area) = 1 ERU	\$10.53	\$11.43
Tier 3 (4,001-7,000 s.f. of impervious area) = 1.5 ERU	\$15.80	\$17.15

Table 2: Stormwater utility residential tiers.

2. NON-SINGLE FAMILY RESIDENTIAL parcels and RESIDENTIAL PARCELS with greater than 7,000 s.f. of impervious area are charged based on the actual amount of impervious area, measured in ERUs, rounded to the next whole ERU.

Non-Single Family Residential	2017 Monthly Fee	2018 Monthly Fee
Per ERU (3,300 s.f.)	\$10.53	\$11.43

3. VACANT PARCELS are charged .3 ERU.

Vacant (unimproved) Parcels	2017 Monthly Fee	2018 Monthly Fee
0.3 ERU	\$3.16	\$3.43
