



# 2024 IAFSM Annual Conference Exhibitor Registration Information

**March 12-13, 2024  
Peoria Civic Center**

You are invited to exhibit during the 2024 Annual Conference of the Illinois Association for Floodplain and Stormwater Management (IAFSM). Speakers from federal, state, regional, and local agencies and the private sector will share their knowledge on current programs and the latest techniques. The conference provides both an excellent training forum and an opportunity to meet and talk with other floodplain and stormwater management professionals. Over the last few years, our conference has brought up to 500+ participants and 25 exhibitors. We will repeat our proven approach to encourage visitors to the exhibits. Registrants will receive an exhibitor’s card. If each private exhibitor signs the card, the registrant will be eligible for the door prize drawing. Signatures are collected from the exhibitors during the conference on Wednesday and during the social hour that evening. We collect over 200 fully executed exhibitor cards each year. The door prizes will be drawn and announced on Wednesday.

The exhibitor registration fee is for a ten-foot by ten-foot space. This includes registration for the conference for one person and includes that individual’s IAFSM yearly membership. If you require more than one ten feet by ten feet space you will need to pay an additional exhibitor fee, which includes an additional attendee’s registration and IAFSM yearly membership. If you would like more than one individual to help with the booth, the extra person will need to register for the conference (we do have a one-day rate for the extra person if needed).
