This position is responsible for developing feasible solutions to water resource problems including flood control, drainage, water supply, low flow augmentation, stream restoration, and recreation analysis; investigation of complaints by the general public concerning drainage and other water resource problems; and completion of complex engineering assignments involving the hydraulics of reservoir systems, hydraulics of channel modifications, determination of recreational demand, economics (benefits and costs) associated with water resource projects, and watershed hydrology.
