# 2011 IAFSM Awards and Recognition

During the annual conference in Normal, IAFSM took time to honor our coworkers and colleagues who have supported and encouraged good floodplain and stormwater management here in Illinois.

# Floodplain Manager of the Year

This award recognizes outstanding individual efforts and contributions at the local level. The award honors an individual responsible for the development of a distinguished local program or activity, or someone who struggles to implement flood hazard reduction at the local level in the absence of sophisticated programs and support.

Michael Sutfin of the City of Ottawa was awarded the IAFSM Floodplain Manager of the Year Award. Sitting at the confluence of the Fox and Illinois Rivers, the City of Ottawa is one of Illinois' most flood prone communities. Ottawa has frequent flood events. Upstream development on both of these watersheds is only going to increase Ottawa's susceptibility to flooding. Following two major floods in 2006, Mr. Sutfin and local officials set about to change the community's exposure to floods. Among other things, Mr. Sutfin and the City have: bought out or mitigated many of the most flood prone structures in town, formed an active local flood committee, held public meetings on flood maps, established a flood warning system, and conducted city wide surveys to better identify flood risk. The City has joined the Community Rating System Program at a Class 5. Ottawa is expected to soon rise to a class 2 community, making it the best in Illinois and #2 in the nation!

# **Stormwater Management**

Awarded to a floodplain manager, an individual, a group of individuals, a consultant, or an agency who improved stormwater management or reduced urban flood risks through creative engineering, regulatory measures, or other approaches. The award can also be considered for someone who struggles to implement flood hazard reduction at the local level in the absence of sophisticated programs and support.

This year's Stormwater Management Award winner is the Village of Montgomery. The Village has developed and implemented a stormwater management and biodiversity program that both encourages natural landscapes and helps to reduce flood losses. Montgomery is a rapidly growing community. Like many communities in this part of the state, loss of open space, aquifer recharge, stormwater management, and pollution control are ongoing concerns.

The Village of Montgomery Naturalized Stormwater Management Facility Design, Planting and Management Plan Guidelines has become a model program. The same plan was awarded the U.S. Environmental Protection Agency and Chicago Wilderness 2010 Conservation and Native Landscaping Award.

#### Mitigation

This award is given to an individual or community that has encouraged flood hazard reduction through a buyout program, retrofitting, preparation of a mitigation plan, or other similar mitigation efforts.

The Village of Machesney Park was recognized for their efforts in obtaining grants to acquire flood-prone structures and convert the property into open space. The Village received a grant of \$3 million from the Illinois Emergency Management Agency (IEMA) to acquire 36 properties and \$1 million in matching funds from the Department of Commerce and Economic Opportunity. The Village has submitted a request for an additional \$1.6 million from IEMA to acquire additional properties.

Special recognition was given to Tammy Scott, of McMahon Associates, for her excellence in preparing the applications; to Karen Lemmons, Community Development Director, for her overall management of the project; and to Jack Peterson, land acquisition agent, for his role in implementing the project.

The Village has fought hard to represent the interests of the property owners.

#### Journalism and Public Education Award

This award is generally given media outlet that has produced floodplain or stormwater management special features during the year. The award can include individuals or agencies who have contributed to public awareness of floodplain or stormwater management issues.

This year's Journalism award goes to the Ottawa Delivered. Ottawa Delivered is a 15,000-circulation weekly interactive newspaper and daily online news service covering Ottawa, IL and its surrounding communities. They publish a daily internet paper with constantly streaming stories. Once weekly they publish a paper version of all important news of the week. In addition to their own web based media delivery they use the publicly available media such as Facebook, Twitter, etc. They can broadcast news almost as fast as it becomes news.

Ottawa Delivered has attended every Flood Commission meeting in the City of Ottawa. The paper has been instrumental in developing and implementing the City Flood Threat Recognition and Response Plan. The editor now has the ability to send out an alert via all social media systems including emails the 7000 email auto subscribers.

The paper is very accurate in their reporting of flood activities in the community. The City has used the paper to reach out to the public to inform them of significant changes in the floodplain maps. Ottawa Delivered did a stellar job in reaching the public with very accurate information.



# **Lifetime Achievement**

This award is the IAFSM's highest honor. It is reserved for outstanding longtime floodplain managers. These individuals' long-term contributions have made a noticeable impact on floodplain and stormwater management efforts in the State of Illinois. This award is not always given on a yearly basis.

IAFSM's most prestigious award was presented to Richard J. Roths. Rich's professional work started in planning in Winnebago and then DeKalb Counties. Rich went on to work at the state level as a local floodplain programs field advisor. Rich was instrumental in helping local officials better understand floodplain management. Rich also worked for Northern Illinois Planning Council, adding to their credibility as a floodplain management agency. Rich was one of the seven founding members of the Illinois Association for Floodplain and Stormwater Management. Rich also helped design the Association's Certified Floodplain Manager program in 2000. Rich moved on to the six states in FEMA Region V. With experience in floodplain management and planning, Rich was a natural leader in planning activities and mitigation projects. Finally Rich moved on to work for URS, an international consultant on mitigation.

# **Counties Make Impressive Progress with Hazard Mitigation Plans**



Mitigation planning in Illinois continues to show very impressive progress. The 2008 flooding events exposed the need to develop mitigation plans if a long term recovery was going to be successful. In just the last three years the State has seen a 300% increase in approved plans. In 2008, 17 Counties were ineligible for hazard mitigation grant funding because they did not participate in the NFIP. Illinois has decreased that number to 13, and all four counties that recently joined the NFIP are in the process of getting hazard mitigation plans approved.

Three years ago, 43 counties were not pursuing mitigation planning. Through a partnership with Federal, State and Local governments, as well as Floodplain Management groups and Emergency Management Agencies, 33 of those 43 counties have begun the initiative. By 2012 we expect to have approved County Hazard Mitigation plans for nearly 80% of the State. Our goal going forward is simple: every county should have a hazard mitigation plan. I am pleased to say that we are very close to meeting that goal.

# The Ups and Downs of Levees:

# GPS-Based Change Detection, Middle Mississippi River, USA

ABSTRACT: Changes in levee-crest elevations were measured along 328 km of Mississippi River levees between St. Louis, Missouri, and Cairo, Illinois, in 1998 and 2007. We also compared 1998 and 2007 survey data with 50 yr flood elevation profiles to assess levels of levee protection. Levee heights, stability, and safety are nationwide concerns, especially since Hurricane Katrina and floodwall failures in New Orleans, Louisiana, in 2005. The majority of surveyed levees were stable at the centimeter to decimeter level during the 9 yr measurement interval. Change was measured in other areas, including increases of as much as 1.49 m and decreases of as much as 1.26 m between 1998 and 2007. The increases corresponded to local crevasse repairs, small scale road maintenance, and larger levee-raising projects. Decreases in levee elevations are interpreted as small-scale surface erosion and larger compaction or subsidence of levee and/or foundation materials. Levee crests in 2007 were locally as much as 2.0 m below the 50 yr floodgrade elevations. Levee degradation reduces protection levels for floodplain residents, often without easily visible symptoms. Intentional levee raising without necessary studies, engineering, or permitting has a range of potential negative impacts including both a false sense of security and the potential for exporting flood risk to neighboring levee communities. Regional surveying of levee elevations and change over time can provide a preliminary tool for assessing levee conditions, stability, and compliance with levee regulations.

# Am I in the Floodplain? There's an App for That!

The first-ever FloodMap Mobile app for smartphones instantly summarizes flood risk information from FEMA, giving users a full suite of tools that will allow them to assess a property's flood hazards to help keep businesses, family and property safe.

Developed by PBS&J, FloodMap Mobile relies on the smartphone's GPS to pinpoint where a person is standing or allows the user to type in an address. The app opens a map of the area's FEMA-defined floodplains and summarizes additional data about estimated flood insurance costs, links to insurance agents, USGS and NOAA stream gauge records and links to critical FEMA information.

Josh Price, senior project manager for flood hazard management at PBS&J, says, "Federal, state and local governments have spent years creating detailed flood maps designed to create greater community awareness and prevent or mitigate potential disasters. With FloodMap Mobile, we've put the data and analysis on a smartphone so users can evaluate risk anytime from the phone that is already in their pocket."

All three provide rates at a reduction from the average flood insurance premium, and agents must verify that a policy holder is eligible. # **CRS Users Group News**

The CRS Users Group is made up of CRS Coordinators and others who work with the Community Rating System in Illinois communities. The IAFSM Community Rating System (CRS) Committee facilitates the meetings. The Community Rating System is a program that earns flood insurance discounts for residents by a community's actions toward exceeding minimum NFIP requirements and meeting three goals:

- 1. Reduce flood losses;
- 2. Facilitate accurate insurance rating; and
- 3. Promote the awareness of flood insurance.

The CRS Users Group held their third meeting on October 28, 2010 in Ottawa. The group heard presentations on Flood Warning Programs, including South Holland's program which is the highest scoring program of its type in Illinois; Drainage Maintenance Programs; and administration of substantial damage issues by guest speaker Paul Osman of IDNR-OWR.

The group met again during the annual IAFSM conference held recently in Normal. One of the sessions on Thursday morning was designed for the group, covering substantial improvement and substantial damage, and determining when a structure is "reasonably safe from flooding". The group also gathered for dinner on Wednesday evening at the conference.

## **Interested in a Local EMI Class on CRS?**

Are you interested in taking a local EMI class on Community Rating System? Big changes will soon be made to the CRS program. This EMI class describes activities eligible for CRS credit, how a community applies, and how a community can improve its classification. It will be very important for current CRS communities, for communities interested in joining CRS, and for consultants who assist CRS communities.

The EMI class will cover the new CRS program changes in depth. The class is four days in length and provides 12 CECs. If taught on 4 consecutive days, CRS credit may also be given to an attending community. An alternative is to offer the class one day a week for four weeks, without EMI credit but still eligible for CECs. The class will be held in Illinois, in a location to be determined based on the locations of those who wish to attend, and will probably be held in the spring of 2012.

To attend the EMI class, you must be a CFM, or have completed EMI E273, or be a full time floodplain manager with more than 2 years of full time experience. Workshops will be offered later regarding the CRS changes, but they won't offer CRS points and won't cover the subject in as much detail as the EMI class will.
